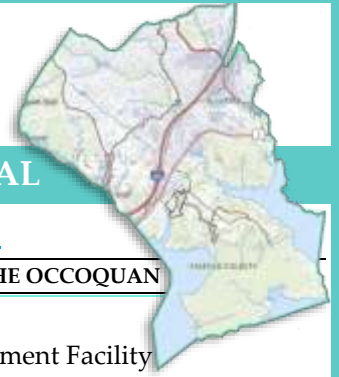

HOUSING PROPOSED FOR WESTERN EDGE OF POHICK CHURCH PROPERTY

Christopher Land LLC with the Pohick Episcopal Church is proposing to develop 17.5 acres of previously undeveloped land into 49 single-family homes. The plan was presented to the SCF Land Use Committee in late August. Several approvals, including from the Architectural Review Board, will be necessary before construction can begin. It would be called Cunningham Woods Reserve and funds from the property sale would support the Church endowment.



ROAD SHARK CAMPAIGN ENDS AUGUST WAVE, NEXT WAVE IN OCTOBER

Fairfax County and Virginia State Police completed the 3rd wave of their Road Shark Traffic Safety campaign in August, resulting in 16,235 citations and warnings. This nearly doubled the number from the same period last year. The high-visibility initiative aims to combat speeding, reckless driving, and other unsafe behaviors throughout the County. Wave 4 will begin on October 12th, ending on the 18th.

- Residents of Virginia, over 18, who are U.S. Citizens and not registered and active in another state are eligible.
